
# Annual Report 2008 – 2009

#### Structure, Governance and Management

The Valerie Taylor Trust is governed by a constitution adopted on 5 September 2007 as amended on 16 December 2007.

The charity is managed and administered by a Management Committee. The Management Committee for the year 2008-2009 comprised of elected and coopted members who are also the trustees of the charity.

The chart below indicates the organisational structure of the Valerie Taylor Trust for the year 2008 - 2009:



#### Recruitment of the Management Committee

At the first annual general meeting held on 9<sup>th</sup> March 2008 all members of the Management Committee stood down and an election was then held to elect eight members for the year 2008-2009. At the Management Committee meeting held after the annual general meeting, a further member was co-opted to the Management Committee.

At the 2008-2009 annual general meeting one third of the members of the Management Committee will stand down but will be eligible for re-election. The Management Committee may also appoint up to three co-opted members.

All members of the Valerie Taylor Trust are eligible to become members of the Management Committee. To become a member of the Management Committee, a member of the Valerie Taylor Trust needs to be nominated by another member of the Valerie Taylor Trust and stand for election at the next Annual General Meeting.

### **Our Objects**

The objects of the Valerie Taylor Trust are to financially contribute to the treatment, rehabilitation and reintegration into the community of disabled people in Bangladesh, particularly those in financial need. We also aim to assist with education of the public and relevant health care workers about the problems faced by disabled people and ways in which these difficulties can be overcome.

Total amount raised = £98,208

#### **Financial Review**

Funds are raised by donations, resulting from membership support, fundraising events and Trusts. Expenditure is aimed to promote all these forms of giving, such as providing access on the Just Giving website, Gift Aid envelopes, leaflets and mailing campaigns.

During the period of this report, the total income of the trust was £98,206.

This was comprised of donations and subscriptions totalling £69,356 and £28,754 received from other charitable activities. An additional amount of £96 was generated from Bank Account Interest.

The charity made grants worth £74,574 to the Centre for Rehabilitation of the Paralysed in Bangladesh during 2008-2009.

Expenses related to supporting this giving were a total of £3,329. The balance of cash funds remaining were £20,304.

The Trust does not hold any reserve funds and there were no deficits during the period of the report. The trust does not currently have an investment policy.

# Fundraising Campaign 2008 – Valerie's Vision

In 1971, Valerie Taylor had a vision. There was a need for rehabilitation services for disabled people in Bangladesh, and by the very nature of the spinal cord injuries she witnessed it was the poor who were most commonly a victim of it. Valerie's vision was to be able to provide free care for these poor spinal cord injured people.

Since starting the Centre for the Rehabilitation of the Paralysed (CRP) in 1979, Valerie's vision has become a reality. Now with 100 in-patient beds at its main headquarters in Savar, CRP provides an amazing service to those who would not otherwise receive it.

As 2008 was our first full year in existence, the Valerie Taylor Trust decided our fundraising campaign should mirror Valerie's original vision. At our inaugural meeting in September 2007, Valerie told those present that the cost for one inpatient bed per month was £44.00. As there are 100 in-patient beds at CRP, this multiplies up to £4400.00 per month to be able to provide free treatment to some of the poorest members of society in Bangladesh.

The Valerie Taylor Trust therefore decided that our initial campaign should look to provide these much needed core funds for CRP and that our member's donations could be able to be used to provide this service. We set our fundraising target for this year at getting a regular income of £4500.00 per month from mandated bank transfers and standing orders in order to meet this goal.

At the end of the financial year, our monthly average from mandated bank transfers and standing orders is just below £1,000.00.

Although the Trust targeted regular donations, various amounts given throughout the year have helped us to exceed our initial fundraising target. In 2009, we will continue to push the need for regular donations and work towards our goal of sustainable incoming resources through regular giving.

#### Achievements

- Membership of the Valerie Taylor Trust currently stands at 130, an increase of 34 members on the previous year.
- Members, donors and supporters of the trust have made over 1000 individual donations during the year 2008 – 2009
- Grants worth £74,574 were sent to The Centre for Rehabilitation of the Paralysed in Bangladesh.
- Re-claimed over £8,431 from gift aid eligible donations from HMRC.

#### Fundraising Activities

- Valerie Taylor carried out a highly successful fund and awareness raising tour in many parts of the United Kingdom.
- A fundraising concert was held at The Royal Scottish Academy on 21<sup>st</sup> February 2009 to raise funds for the Valerie Taylor Trust.
- Additional fundraising events held in Glasgow, Marden and Bicknoller to name a few....
- Started an academic year long fundraising partnership with a number of primary schools to raise funds and increase awareness of the trust.
- Raised money via our online fundraising partnership with Justgiving.com This is thanks to Marathon runners, Rickshaw riders, Mountaineers and Single donations.
- VTT has also increased the amount of promotional material that is available to aid fundraising activities. This includes 2 newsletters (Spring 2008 & Spring 2009), a membership leaflet, a legacy leaflet, gift aid envelopes, 3 DVDs, sponsorship forms and fundraising certificates.

#### **Trustee Activities**

- Held regular (quarterly) Trustees meetings.
- A number of VTT Trustees visited our main benefactor, the Centre for Rehabilitation of the Paralysed in Bangladesh during the year 2008-2009.

I report on the accounts of the Trust for the year ended 30 April 2009, which are attached.

#### Respective responsibilities of trustees and examiner.
