Nearly two years on, work helping the victims of the Rana Plaza disaster is ongoing. 509 people have received treatment from CRP either as an inpatient or out-patient. This includes medical intervention, rehabilitation and the provision of prosthetic limbs. 389 people have completed vocational training, an essential service for those unable to return to their previous jobs. The generous donations from our supporters have helped to make this support and assistance possible.


Annual Report 2014 – 2015

Structure, Governance and Management

The Valerie Taylor Trust is governed by a constitution adopted on 5 September 2007 as amended on 16 December 2007.

The charity is managed and administered by a Management Committee. The Management Committee for the year 2014-2015 comprised of elected and coopted members who are also the trustees of the charity.

The chart below indicates the organisational structure of the Valerie Taylor Trust for the year 2014 - 2015:



Recruitment of the Management Committee

At the 2014 annual general meeting, two members of the Management Committee stood down, but one was willing to be re-elected, and a valid nomination was received for another member and accordingly these two were elected. At the Management Committee meeting held after the annual general meeting, two further members were co-opted. A further member was co-opted on 11th October.

At the 2015 annual general meeting one third of the members of the Management Committee will again stand down but will be eligible for re-election. The Management Committee may also appoint up to three co-opted members.

All members of the Valerie Taylor Trust are eligible to become members of the Management Committee. To become a member of the Management Committee, a member of the Valerie Taylor Trust needs to be nominated by another member of the Valerie Taylor Trust and stand for election at the next Annual General Meeting.

Our Objects

The objects of the Valerie Taylor Trust are to contribute financially to the treatment, rehabilitation and reintegration into the community of disabled people in Bangladesh, particularly those in financial need.

We also aim to assist with education of the public and relevant health care workers about the problems faced by disabled people and ways in which these difficulties can be overcome.

The Trustees have decided that at the moment the best way of fulfilling these aims is by making grants to the Centre for the Rehabilitation of the Paralysed (CRP).

Total amount raised = £269,928

Financial Review

Funds are raised by donations, resulting from membership support, fundraising events and Trusts. Expenditure is aimed to promote all these forms of giving, such as providing access on the Just Giving website, Gift Aid envelopes, leaflets and mailing campaigns.

During the period of this report, the total income was £269,928.

This consisted of donations and subscriptions totalling £151,807, reclaimed tax as Gift Aid of £9,163, £26,413 from other charitable activities, and £82,527 from companies.

Expenses related to supporting this giving were a total of $\pounds4,092$. The balance of cash funds remaining was $\pounds31,155$.

The Trust does not hold any reserve funds and there were no deficits during the period of the report. The trust does not currently have an investment policy.

VTT Income stays higher

The tragic collapse of the Rana Plaza building in April 2013 led to a big increase in VTT's income in Financial Year 2013-4 as individuals and companies responded generously to the extra needs for treatment and rehabilitation.

We didn't then know if income would fall back to pre-2013 levels in Financial Year 2014-5 as memories of the disaster receded. In the event, it hasn't. The Direct Transfer of funds to CRP was £234,000, still a 49% increase on the 2012-2013 transfer of £157,000 and only 15% less than the record transfer of £276,500 in 2013-2014.

Admittedly these totals don't tell the whole story: most of the growth in transfers compared with 2012-2013 has been to Restricted rather than Unrestricted Funds, showing that as result of the Rana Plaza disaster VTT has become better known as a reliable conduit for funds to CRP. This is basically positive but it does impose extra work on the CRP Accounts Department to keep track of the expenditure from each Restricted Fund and report it back to VTT.

Nevertheless, through the generosity of our supporters, VTT's contribution to Unrestricted Funds, which helps CRP to pay for the poorest Spinal Cord Injury patients, was higher than in 2012-2013. This was assisted by events organised to coincide with Valerie Taylor's visit to the UK in the Spring and Summer of 2014, which raised £23,000, but also by many other sponsored events unconnected with her visit.

Meanwhile CRP continues to develop in new ways. This year saw the establishment of a School of Prosthetics and Orthotics at CRP, the first one in Bangladesh, and the first cohort of 10 students are waiting to sit their first professional examinations.

In November 2014 CRP itself hosted the 13th Asian Spinal Cord Network (ASCoN) international conference, and several members of CRP staff were given awards for their research in the course of the conference. This reinforces CRP's reputation as a Centre of Excellence for the treatment of Spinal Cord injuries in the Asian Region.

Given such successes and the ongoing treatment and rehabilitation achieved with the help of VTT grants, the Trustees consider they have complied with their duty under section 4 of the Charities Act 2006 in regard to public benefit, which refers to the advancement of health and the relief of those coping with disability.

Achievements

- Membership of the Valerie Taylor Trust has risen to 240, of whom 200 give by Standing Order.
- Grants to CRP totalled £234,000, only 15% less than the grants in the preceding financial year as a result of the public response to our Rana Plaza appeal.
- Around 30 volunteers from the UK visited CRP in the course of the year, and they often make a very valuable contribution there. Where possible VTT helps support them before they go and contacts them on their return.

Fundraising Activities

- Following an appeal night by a number of Bangladeshi restaurants in the Birmingham area, a cheque for nearly £8000 was presented to Valerie for the Trust.
- £3300 was raised in the course of Valerie's visits to the neighbouring parishes of Marden and Boughton Monchelsea in Kent.
- Iain Whitty raised £1200 from sponsors by running the gruelling Northumberland Coastal Marathon.
- Hugh Lambert from Camberley raised £1400 from a sponsored cycle ride.
- The Bangladesh Association of Glasgow held an event in Valerie's honour during the Commonwealth Games and raised £1000 with a raffle and auction.
- The United Reformed Church in Daventry raised a further £4000 through its coffee mornings
- Karen Heaslip, a recent volunteer at CRP, raised £2000 in aid of a project for an Occupational Therapist in Mental Health at CRP.

Trustee Activities

- One Trustee visited CRP, meeting Valerie and Shafiqul Isam, the Executive Director.
- Trustees helped to enable a meeting in Tower Hamlets attended mainly by British Bangladeshis and it is hoped that this will lead to a new active supporter' group.

I report on the accounts of the Trust for the year ended 05 April 2015, which are attached.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.
